## General Specifications for Boat Docks:

Boat docks shall be permitted to extend into the lake only as far as necessary to provide boat access and storage. Water depth will be considered when determining the length. Neither the dock nor the boat shall infringe upon adjacent landowners. Docks must be floating and must be constructed of quality materials approved by SIPC. Wood and metal shall be treated or coated to prevent rotting and corrosion. Floating docks must be securely fastened to the shoreline. No metal, PVC, plastic or similar drum floatation will be allowed. Only Encapsulated Expended Polystyrene (EPS) with an approved coating or Extruded Polystyrene (trade name – Styrofoam) will be approved. Docks must be maintained in an attractive and safe condition. SIPC written approval must be received prior to commencement of any construction. All construction must be completed in accordance with SIPC's plans and specifications. Safety markings visible at night, such as reflectors or lights, must be posted and constantly maintained at the corners and on any portion of the dock extending into the Lake of Egypt. Owner acknowledges that SIPC may amend these minimum specifications from time to time. Any modification required shall be completed within thirty (30) days of any changes in these minimum specifications.

In the space provided on the reverse side, sketch the proposed boat dock, shoreline and neighboring property lines (including the dimensions for the dock and the distance from the shoreline and property lines), identify and note the location and type of any safety markings and identify all construction materials, flotation devices and method of attachment to the shore. Please return the completed application to the SIPC Administration Building or mail to SIPC, 11543 Lake of Egypt Rd, Marion, IL 62959. Applications will be processed for review on the 15<sup>th</sup> of each month and written approval or denial will be mailed to the owner after the 1<sup>st</sup> of the following month.
